

Stablish Foundation helps families create a LEGACY OF PHILANTHROPIC GIVING with a Donor Advised Fund (DAF). A family can create a DAF while they are living that continues after death, or they can create a DAF in their testamentary documents that continues after death. In addition, many parents establish a DAF either before or after death that permits their children to fulfill their own charitable desires and objectives.

The key to creating a Legacy is not based on establishing a DAF; but rather, by creating a flexible Statement of Charitable Intent advising the Trustee of the DAF how the Donor(s) would like the funds to be used for charitable purposes. Typically, a minimum of 5% of the previous year end value is contributed for charitable purposes. Therefore, the Donor(s) need to carefully determine their desires and convey these thoughts to the Trustee with either general or specific requests in the Statement of Charitable Intent.

Stablish Foundation permits the Donor(s) and potentially family members to amend the Statement of Charitable Intent as frequently as they wish. In addition, Stablish Foundation encourages the family to revisit this document a minimum of every five years to ensure that it continues to fulfill the family's charitable desires.

The following is a list of some of the things to consider when creating a Statement of Charitable Intent as part of a DAF:

- How many charities are going to receive a share of the annual 5% distribution? One? Five? When deciding this, you might want to consider the size of your DAF and how much each charity might receive. Would that amount fulfill your specific purpose (if any)?
- When the gift is given to a charitable organization, does the Donor(s) want it to be used for a specific purpose? Specificity of the Statement of Charitable Intent is critical if the funds are to be used for a specific purpose.
- **③** Does the Donor(s) want other family members, such as children, to be involved before or after the death of Donor(s) in advising on the selection of charities?

Once the Donor(s) has created a Statement of Charitable Intent, Stablish Foundation must vet the selected organizations to ensure that they meet the Internal Revenue Service requirements of a charity. This is necessary to make sure the integrity of the DAF is maintained.

The following are some examples of content in existing Statements of Charitable Intent with Stablish Foundation:

- Create an annual scholarship at _____ (a specific university) for only C students in high school, excluding A and B students.
- **②** Create an annual gift at a research institution to perform research on the cause of cerebral palsy.
- Create an annual gift to a small church for capital improvements only and not for the operating budget of church.
- **4** Create annual gifts to general operations of a five different charitable organizations.

As the above indicates, the Donor(s) need to give careful consideration in creating their Statement of Charitable Intent. In addition, review of the Statement of Charitable Intent needs to occur periodically. Stablish Foundation can assist in this detailed process. •

Many charitable organizations encourage Donors to use their foundation as the Trustee of the donor's DAF. The disadvantage of using a specific charitable organization to be the trustee of your DAF is the inability to change your Statement of Charitable Intent since that entity wants to ensure that the funds are ultimately given to their organization. Permitting changes in the Donor's Statement of Charitable Intent is one of the main advantages of a community foundation like Stablish Foundation.
